

**Snyder Township Board of Supervisors  
Regular Monthly Meeting  
December 26, 2019**

The monthly meeting was called to order by Vice-Chairman Michael Holt in the Snyder Township Building, 15706 Route 28, Brockway, Pennsylvania at 7:00 PM. Vice-Chairman Holt welcomed everyone present and led the group in the Pledge of Allegiance to the Flag.

The Organizational Meeting will be January 6, 2020 at 7 PM at the township office.



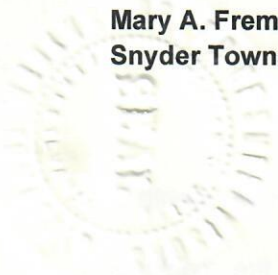
**ADJOURNMENT**
