The monthly meeting was called to order by Chairman Michael Holt in the Snyder Township Building, 15706 Route 28, Brockway, Pennsylvania at 7:00 PM. Chairman Holt welcomed everyone and led the group in the Pledge of Allegiance to the Flag.

Supervisors present were Michael Holt and Jeremy Bassetti. Absent was Supervisor, Ronald Freemer. Jefferson Co. EMA sent a reminder to have residents properly display their 911 address.

Our 2025 Liquid Fuels Allocation estimate is \$153,247.92.

Gov. Shapiro signed Act 94 on October 2nd. It bumps up the township supervisor compensation, allowing boards to establish "per-meeting" compensation by ordinance.

The new FEMA NFIP Compliance Audit Program brings significant changes to townships. Each municipality will be visited to establish any floodplain violations.

The minutes from the September meeting were approved as read.

The October Treasurer's Report was read with balances as of November 2, 2024. General Fund balance \$746,853.55; Liquid Fuels Fund balance \$4,370.59. Jeremy Bassetti motioned to acknowledge all supervisors receiving the Treasurer's Report with Michael Holt second. All supervisors voted yes and the motion carried.

Public Participation

Don Henrichs of Noble Environmental, Greentree Landfill, informed the board that they plan on purchasing the rail yard along Route 219. A Transfer Station Permit will have to be submitted to DEP. The Township will be notified as plans progress.

Brockway Rec. Board Member, Jake Rindosh, updated the Township with their 2025 Budget.
